The Bankers have stipulated full settlement of Company's dues without any haircut as well as up to date dues of Associate Company M/s Patspin India Ltd. At the Shareholders Meeting held on 12.09.2024, the Company has obtained their approval to lend an amount up to Rs.10.60 Crores to M/s Patspin India Ltd. Since there was substantial delay to conclude the deal, the Company has again approached the Shareholders by way of a Postal Ballot to lend an additional unsecured loan up to Rs. 4 Crores and the resolution was passed by way of postal ballot on 19.02.2025
